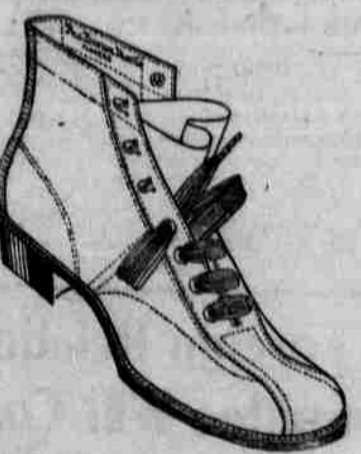

GOMPERS ASKS

But when you can't buy shoes for your family, it's pretty hard to think only of patriotism."

In the deadlock between the United States Steel Corporation and the union representatives no effort will be overlooked to reach a peaceful settlement. Unless Judge Gary grants the union committee a conference, however, the outlook today was for a strike. The letter forwarded to Gary Wednesday night, which gives him until August 30 to grant the union request, was written following a long conference between President Gompers and leaders of the steel men. It is understood that the position outlined in this letter represents Gompers' position. One labor authority declared today that Gary could avert a strike by writing a letter stating that he would not interfere with the organization of men in the steel plants.

Warren S. Stone, head of the engineers' brotherhood, would not venture a prediction today as to what the result of the shopmen's letter will be. He pointed out, however, that it is a brotherhood policy not to go on sympathetic strikes, and that as the engineers have no wage matters pending, this policy would be adhered to. Other brotherhoods, however, have wage demands now up or pending. Stone pointed out that if the government should fail in its ninety day period to lower prices, strikes would bring on more serious results than at present, as winter will be coming on with its attendant hardships.

"It isn't a matter on which a solution can be found two or three years from now," said Stone. "Something must be done immediately if men and their families are to be able to live. In their families are to be able to live. In are two to three cents higher now than before 'the fair price campaign' was started. I'm afraid prices won't come down materially until they put some profiteers in jail."

Stone with the representatives of other brotherhoods and affiliated railroad organizations held a conference with Glen E. Plumb last night. Stone said the Plumb plan league was gaining from 2900 to 3000 new members daily.

Representatives of the actors, stage hands, musicians and movie operators were here today, and it was expected they would go before the A. F. of L. executive committee, which is now meeting.

Charges that the steel companies are discriminating against and discharging union workers in an effort to force a strike were made in a telegram sent out by the steel men's committee today.

They advised holding the men at work, however, until all means of settlement had been exhausted. The telegram addressed to James Mulholland,

secretary of the Allied Iron and Steel workers council, Gary, Ind., follows:
Your telegram received stating that steel workers are being discriminated against and discharged wholesale for purpose of forcing strike. The steel companies are doing the same in many other places, but in spite of this permit a try to hold the men at work until all amicable means of settlement has been exhausted. The executive council of the American Federation of Labor is negotiating for a conference with President Wilson today. The steel companies show by their action a determination to force the issue before the president has had a chance on the merit of the controversy. We are doing all possible to secure justice for the men and to prevent the national disaster of a general strike in the steel industry. Do not strike under any circumstances until the strike date has been set by your committee.
The telegram is signed by John Fitzpatrick, D. J. Davis, E. J. Evans, William Hannon and William Z. Foster.
